- Education: In search of good educational facilities several families are moving to the other places and settling in those places just for the sake of education only.
- Security: Security is also one of the reasons for the migration throughout the world. The unstable places or the place where the internal conflicts, political instability, clashes among the tribes, ethnicity, etc will come under this. These types of migrations can be seen in JK and Assam.
