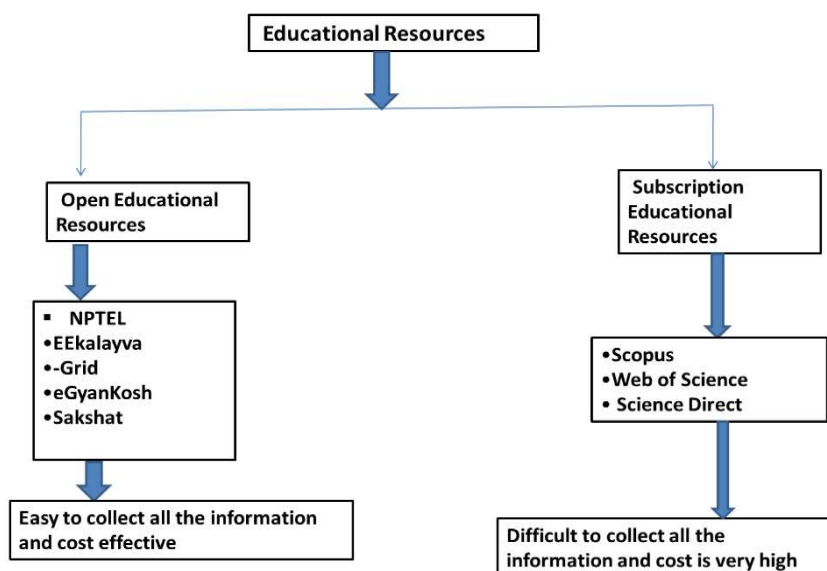


Figure 1: Flowchart of Educational Sources.

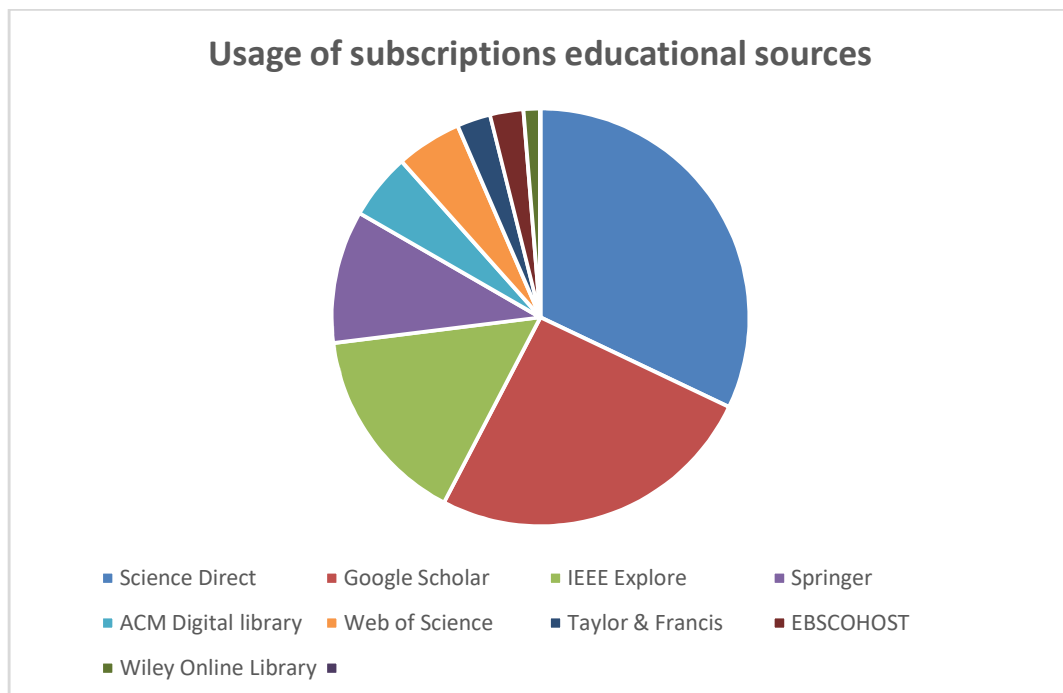


Figure 1: Usage of Subscription Educational Sources.

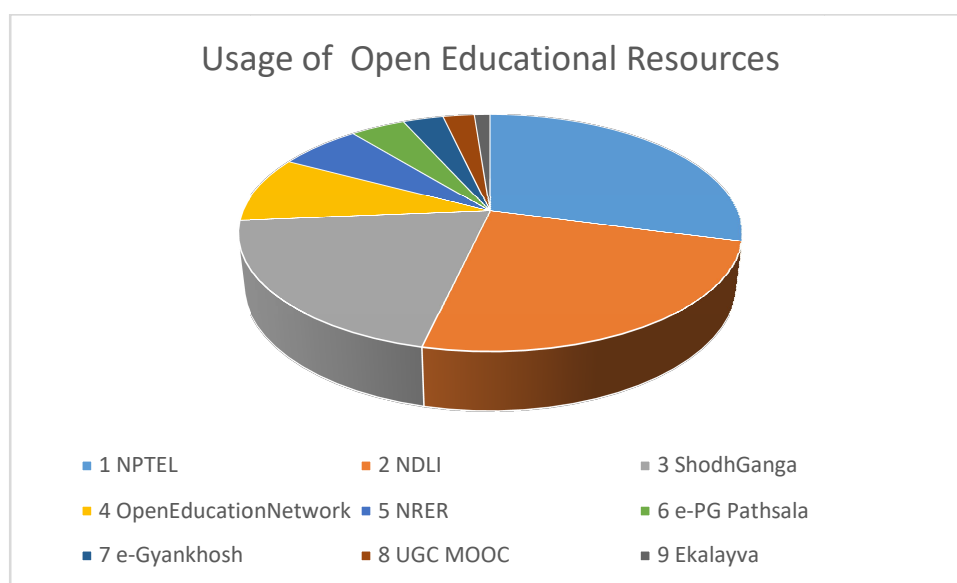


Figure 2: Usage of Open Educational Sources.
